

**Tentative Minutes of the
Ogle County Liquor Commission Meeting**

April 16, 2019

Chairman Gouker calls the meeting to order at 4:00 p.m. Present: Chairman Kim Gouker, John Finfrock and Greg Sparrow. Others: County Clerk and Recorder Laura J. Cook, Youman, Jason and Heather Stombaugh of J&H Restaurant, Inc. and Rebecca Jones of Pine Creek Escape Co..

Approval of Minutes – August 20, 2018: Motion by Finfrock to approve the minutes as presented, 2nd by Sparrow. Motion carried.

New Business:

- Review and Approve 2019 – 2020 Ogle County Liquor Licenses & Video Gaming Permits

The Liquor Commission reviews the applications as presented. County Clerk Cook states Costa's and White Pines Resort did not reapply for the 2019 – 2020 liquor licenses. Cook also informs the commission that the Chana Tap turned their license right before the meeting today without payment. Sparrow moves to approve the renewal of the County Liquor Licenses and Video Gaming Permits as presented and Chana Tap is contingent upon payment, 2nd by Finfrock. Motion carried.

- J&H Restaurants – Sledgehammer's – Jason and Heather Stombaugh

The commission reviews the paperwork presented. County Clerk Cook states according to the Planning and Zoning Department states they are going through the Regional Planning Commission and Zoning Board of Appeals for a Special Use Permit.

Stombaugh asks about the need to go through the process to obtain a Special Use Permit since the property is Zoned B-1. The recommendation from the Planning & Zoning Department has been presented to the commission with comments in regards to the zoning issue. County Clerk Cook states on the original application a year ago, they were informed of the need to go through this process. The Stombaugh plead their case that they intend to open the establishment June 1st and they need to work with the Amusement Company. Chairman Gouker will get in touch with Planning and Zoning Administrator and inquire about the recommendation on the investigation sheet.

Sparrow moves to approve the liquor license and video gaming permit contingent upon approval of the Special Use Permit from the Regional Planning Commission, Zoning Board of Appeals and the County Board, 2nd by Finfrock. Motion carried.

- Pine Creek Escape Co – Rebeca Jones

The Liquor Commission reviews the recommendations from the various county offices. Sparrow moves to approve the liquor license as presented, 2nd by Finfrock. Finfrock asks where this is located. Ms. Jones states this is the Wedding Canyon and Cabins located on W. Pines Road across from the State Park. Motion carried.

- Ralphie and LuLu’s – Ralphie and LuLu’s, Inc. - Marilyn Balch

The Liquor Commission reviews the Catering License request from Ralphie and LuLu’s. Sparrow moves to approve the liquor license as presented, 2nd by Finfrock. Motion carried.

Old Business

County Clerk Cook informs the commission that Costa’s did not reapply for the new catering license. Finfrock moves to approve the catering liquor license for Costa’s contingent upon proper paperwork and fee, 2nd by Sparrow. Motion carried.

County Clerk Cook informs the commission that Beth Henderson from White Pines Resort did not reapply.

Sparrow asks about the information County Board member Pat Nordman sent in regards to Liquor License fees. There was discussion as to who it was e-mailed to and Sparrow was the only person with the information. This will be a future topic of discussion.

The Liquor Commission decided they would deliver the 2019 – 2020 Ogle County Liquor Licenses and Video Gaming Permits April 23rd – 24th.

Sparrow moves to make a recommendation to the County Board to change 10 am start time to 8 am for liquor service on Sundays for the Class H Golf Course Liquor License. Gouker seconds. Motion carried.
