#### Call to Order

Chairman Gouker calls the Ogle County Board Meeting to order at 5:30 p.m.

# **Approval of Minutes**

Chairman Gouker asks for a motion to approve the December 3, 2012 Ogle County Board Organizational Meeting minutes. Janes moves to approve, McKinney seconds and the motion carries on a voice vote.

# Presentation – Lee County Enterprise Zone #9 – Amending Ordinance and Amendment #16 – O-2013-0101

Chairman Gouker presents O-2013-0101 regarding the Lee County Enterprise Zone Amending Ordinance #9 and Amendment #16; which was presented at the December County Board meeting. Chairman Gouker introduces John Thompson to answer any questions regarding this Ordinance.

Thompson states the purpose of amending the Lee County Enterprise Zone #9 Ordinance and Amendment #16 to the Intergovernmental Agreement is to add territory to the zone for the purpose of accommodating a manufacturing project which will employ approximately 100 people. Ogle County will be the seventh unit of local government to pass this and the City of Amboy will act on this on Monday.

Ogle County State's Attorney Mike Rock thanks the members of the County Board for their vote of confidence in making this appointment. Rock also thanks the support of his family, friends and co-workers from the State's Attorney Office.

# Presentation – Amy Jo Clemens – Lee/Ogle Regional Superintendent of Schools – Annual Report

ROE Superintendent Amy Jo Clemens presents the Lee/Ogle Regional Office of Education Annual Report which was included in the packets. Clemens reviews information included in the Annual Report and invites Board Members to visit her facility in Grand Detour.

Welty asks what role the ROE has regarding safety and security in our schools in Ogle County regarding security threats. Clemens states there are school code rules regarding the type of drills the schools need to have and the building plans for all schools are on file at the State Police Office. Every year the school district has to have a meeting which involves all of the emergency stake holders and everyone signs off on the plans and they are filed with the ROE. There is a trainer provided by the State of Illinois at no charge to help them go through their crisis plans.

# Presentation - Curtis D. Cook - Ogle County Engineer - Annual Road and Bridge Report

County Engineer Curtis D. Cook presents the Road and Bridge Annual Report and the hard copy of the report has been distributed to the all board members. The PowerPoint presentation highlights the 2012 Construction Projects throughout the county. Cook informs the board the Ogle County Highway Department will be celebrating its 100<sup>th</sup> Anniversary later this year and every month there will be a trivia question. Cook asks if anybody knows where Convict Hill is in Ogle County. Cook states it is on Ridge Road County Highway which is on the North side of Grand Detour on your way back to Oregon and Mt. Morris. Cooks asks if they know why it is called Convict Hill. Meyers states convicts constructed the road. Cooks states that is correct, back in July of 1915 the first convict labor gang came to Ogle County from the State Penitentiary in Joliet to build that stretch of road.

# o <u>Electrical Aggregation – Update -O-2013-0102</u>

Chairman Gouker presents O-2013-0102 regarding Electrical Aggregation. This would be placed on the Consolidate Election Ballot in April of 2013. Chairman Gouker asks Assistant State's Attorney Aaron Wiles to speak on behalf of the State's Attorney Office regarding the findings of placing this question on the ballot. Wiles states there has been quite a bit of research regarding the question if the same question can be placed on the ballot twice within 23 months. Wiles states Lee County just voted on this issue and the Village of Poplar Grove has also come to the same conclusion and vote on the issue. The State's Attorney Office has spoken to the legal department of State Board of Elections and they have concurred Electrical Aggregation does not fall under the 23 months waiting requirement. Typer makes the motion to approve O-2013-0102 and Janes seconds.

Hopkins says Pine Creek Township passed this at the last election and the contract looks like the electric power will be a 1/3 less to all of the residents of Pine Creek Township. Chairman Gouker states the City of Byron also passed this and they also see about a 1/3 savings. Chairman Gouker asks the representative for the Electrical Aggregation be sure to educate the voters of Ogle County. The motion carries on a voice vote. (Placed on file)

#### <u>U.S. Marshall's Per Diem Contract – R-2013-0109</u>

Chairman Gouker presents R-2013-0109 regarding the U.S. Marshall's Per Diem Contract. Welty moves to approve R-2013-0109 and Sparrow seconds. Chairman Gouker asks Sheriff Harn to explain the resolution.

Sheriff Harn states there is a new way the Federal Government figures the per diem rate for the Federal Inmates housed at the jail. There is a new multiplier which allows more of the expenses to be put into the calculations; we may get a housing increase on the per diem. It is stated in the contract with Joseph Summerill and or The Summerill Group, LLC; if the county does not get an increase Summerill does not get his fee.

Petrizzo asks what the duration of this contract is. Sheriff states everything should be taken care of by the first of May and we should see the revenue the first part of June. Chairman Gouker stated the contract with Summerill is a one-time fee. Sheriff states Summerill will give the county a template and negotiate. Then the county can use the template in the future.

McKinney asks what the cost of Summerill contract is. Sheriff states it is \$35,000 and we would roughly see \$175,000 to \$250,000 in the first half of the year. Typer asks the Sheriff if we will get the cost of the contract back within the first quarter. Sheriff states yes.

Welty makes a motion to amend the resolution to include "not to exceed \$35,000" and Sparrow seconds. The motion on the amendment carries on a voice vote.

The motion to approve R-2013-0109 as amended carries on a voice vote.(Placed on file)

Former Long Range Planning Chairman Dennis Williams was contacted and he stated those lines were not necessary since there was a cap on the total amount of reimbursable which is something he requested.
- In a couple of weeks the Bond Call will be completed and we will be saving the county \$2.8 million. Chairman Gouker would like to have an old fashioned mortgage burning in February.
- UCCI Conference Update: There were 20 County Board members in attendance and Ogle County was the top County in attendance. Chairman Gouker states mileage reimbursement information has been turned into the County Clerk's Office; this will not be reimbursed as a meeting. Chairman Gouker thanks all board members who attended.
- Petrizzo compliments new County Board Committee Secretary Courtney Warren and states she did a great job.
