• Spoor Property Lease – 501 W. Washington St – R-2013-0606

Chairman Gouker presents R-2013-0606 regarding the lease for the Spoor Property which is currently housing the business of Andy Reigel. Chairman Gouker reviews information from the lease but we need to discuss the term of the lease. The Executive Committee is recommending a two year lease with the option to extend an additional year; this is ok with Mr. Reigel. There was discussion regarding a three year lease. Chairman Gouker states the plan was to purchase this property so it could be used for expansion in the future.

There was discussion regarding the name of the business. The consensus was not to ask the tenant to change the name. Items I and J will be removed from page two of the lease agreement.

Heuer asks about the security deposit at the bottom of page two. Chairman Gouker states there will not be a security deposit. Reigel is responsible for the repairs to the building and if he leaves the building may be taken down.

Sparrow moves to approve R-2013-0606 for a two year lease with the option of extending one year, Nordman seconds. Chairman Gouker states the lease will be from July 1, 2013 to June 30, 2015. The motion carries on a voice vote. (Placed on file)
