Call to Order

Chairman Gouker calls the Ogle County Board Meeting to order at 5:35 p.m..

Roll Call

The roll call shows McKinney and Typer are absent. Chairman Gouker states McKinney has had a minor stroke and he has been in contact with County Clerk Huntley. County Clerk Huntley states McKinney was getting ready to be released to VanMatre and is doing well. The Invocation is given by Saunders and is followed by the Pledge of Allegiance.

Presentation – County Board – Doreen O'Brien

Chairman of the H.E.W. Committee Dorothy Bowers presents retiring Health Department Administrator Doreen O'Brien with a plaque and thanks her for service to Ogle County. Doreen thanks everyone for attending the Open House for her this evening. O'Brien introduces Lucinda "Cindy" Bauling who will be taking over as the Health Department Administrator. Chairman Gouker thanks Doreen for her service to Ogle County.

Approval of Minutes

Chairman Gouker asks for a motion to approve the May 20, 2014 Ogle County Board meeting minutes. Heuer makes the motion to approve, Bowers seconds and the motion carries on a voice vote.

Approval of Reports

o Personnel Policies and Benefits – R-2014-0607

Chairman Gouker presents R-2014-0607 for the inclusion of the following which was previously adopted by the Ogle County Board:

- Inclusion of Credit Card Policy (R-2013-0807)
- Replace Vehicle Use Policy (July 1, 1994) with Motor Vehicle Driving Policy (R-2012-1012)
 Griffin moves to add P. 2013, 0807 and P. 2013, 1012 into the Personnal Manual

Griffin moves to add R-2013-0807 and R-2012-1012 into the Personnel Manual, Nordman seconds and the motion carries on a voice vote.(Placed on file)

o Employee Right to Privacy in the Workplace Act – R-2014-0608

Chairman Gouker states this Act prevents the employer from asking for usernames and passwords to social media networks or other similar programs; even if a workplace computer is being utilized. Oltmanns makes the motion to approve R-2014-0608, Bowers seconds and the motion carries on a voice vote.(Placed on file)

o Employee Credit Privacy Act – R-2014-0609

Chairman Gouker states this Act prevents an employer from using a credit report for hiring. Nordman makes the motion to approve R-2014-0609, Janes seconds and the motion carries on a voice vote.(Placed on file)

o Illinois Firearm Concealed Carry Act – R-2014-0610

Chairman Gouker states this is coordinating the Ogle County Personnel Manual with the State Law. Nordman makes the motion to approve R-2014-0610 and Hopkins seconds.

Meyers asks if we can enter into closed session to discuss this. Chairman Gouker states this is not something we can enter into closed session to discuss.

Saunders disagrees with the policy as written and would like to add changes to the verbiage.

Welty participated in the Concealed Act Training as well as other County Board members and states this wording comes from the State and he doesn't think we can deviate from State Law. Saunders asks if the County Board members are considered employees of the County. Chairman Gouker states yes we are at this hour. Welty states if you have a concealed carry permit you are permitted to carry a loaded handgun in your car and drive into any parking lot; however, you cannot exit the vehicle with the gun as it must be locked in your vehicle. There was discussion regarding Concealed Carry regulations and Appropriate Carry.

Welty states the County Board does not have to adopt this Resolution as this is a State Law and everyone will still have to comply with the State Law. Chairman Gouker states this is important to have in the county policy.

Meyers makes the motion to table the Resolution and send it back to the Finance and Insurance Committee and bring back to the County Board at the next County Board Meeting and Petrizzo seconds. A roll call vote is called:

Saunders asks if the Department Heads are aware that they are responsible to distribute this information to their employees and have them sign off that they are aware of the changes. Chairman Gouker states a consultant from the insurance company will be coming in the next couple of months who will review this information. There will also be an employee sign off form that will need to be signed that the employee has reviewed the personnel manual. Saunders states according to the Illinois Firearm Concealed Carry Act Policy; "Each office or department of Ogle County shall be responsible for reviewing said policy with each employee. Each employee must sign an acknowledgement form indicating the employee has reviewed a copy of said policy." Who will monitor that the department heads will be handling this, comments Saunders. Chairman Gouker states he will be sure that the department head communicates this with their staff.

The motion carries on a roll call vote.(Placed on file)

Finance:

o IACBMC Employee Life Insurance Program – R-2014-0611

Chairman Gouker presents R-2014-0611 for the Illinois Association of County Board Members and Commissioner Employee Life Insurance Program; this is optional for the county employees. Sparrow moves to approve R-2044-0611, Kenney seconds and the motion carries on a voice vote.(Placed on file)

- List of Banks as Depositories R-2014-0612
 Chairman Gouker presents R-2014-0612 which is a list of Financial Institutions used as depositories of public funds in the custody of the Ogle County Treasurer; this list was supplied by the County Treasurer. Bowers moves to approve R-2014-0612, Welty seconds and the motion carries on a voice vote. (Placed on file)
- o Rockford Area Economic Development Council Membership R-2014-0615 Chairman Gouker presents R-2014-0615 to become a member of the Rockford Area Economic Development Council. Sparrow moves to approve R-2014-0615 and Oltmanns

Meyers asks what is the membership fee to join this organization. Chairman Gouker states it will be \$2,000 a year which will be reviewed by the Finance Committee annually.

Saunders will be voting no; because of our association with Winnebago County the townships in Ogle County pay out more in financial assistance. Saunders doesn't see a benefit to the western part of the county. Chairman Gouker states our employment is tied to Winnebago and Boone counties and this is not designed to help any portion of the county, but we need to explore this opportunity.

Sparrow states GREDCO is a member of RAEDC and has seen the benefits with drawing in Nippon Sharyo into the area. Meyers says he is for anything that will benefit any part of the county and asks for updates periodically. Chairman Gouker and Sparrow will be representing the County and can give a quarterly update to the board.

The motion carries on a voice vote.(Placed on file)

Long Range Planning:

Griffin introduces Gary Dobbs and Greg Suthers of Rockford Structures who have been doing an excellent job on the Sheriff's Administration Building. Griffin states the pictures on the screen are from the project as it is developing. Griffin states Rockford Structures has been instrumental with handling the challenge of the concrete found at the

site which is part of the Change Order this evening. An update has been distributed and sent out today on the project and the challenges they have faced. Griffin has also distributed a project budget sheet to keep track of the expenditures of the project.

o Change Order 001 – R-2014-0614

Griffin presents R-2014-0614 in regards to Change Order 001 for the removal of the materials at the site and Janes seconds.

Welty asks why this wasn't discovered in the borings done on the site. Griffin states there were seven borings done and the material was calcifying, which looked like rubble or rock. Meyers asks if seven borings is typical for a building this size. The representatives from Rockford Structure said yes it is.

The motion carries on a voice vote.(Placed on file)

Chairman Comments:

- o Chairman Gouker comments on the employment status of the Sheriff; as an elected official the Sheriff is elected for a term which ends November 30, 2014 and states the Sheriff reports to the voters. When this situation came to light, I contacted and asked the State's Attorney to research our options and statutory requirements of the position. I have also contacted UCCI and they have their attorneys looking into this as well. The Sheriff is the Sheriff 24 hours a day in or out of the office, which is the same of any elected official. There are situations or events which occur outside of the normal work day. The Sheriff has assured me he will continue to respond to and fulfill his duties of the job. We as a board have no authority and cannot change what has been appropriated by the board. We will continue to monitor that the duties in his office are being fulfilled. The work in that department is being done as we have good people in our Sheriff's Department.
- Chairman Gouker comments on the editorial in the newspaper attacking the County Board. The letter questioned the ethics of the board because we do not take it upon ourselves to remove someone from office or change the appropriated funds because

someone has a problem. This County Board is doing what it needs to do, I as the Chairman will communicate with the Sheriff to be sure duties are being carried out.

- o Meyers states the editorial by Connie Karper does not have the facts correct. The Sheriff has been the President of the Village of Forreston prior to being elected as Sheriff and it is a part-time position. The position at the Forrestville Valley School District will not be full-time until his term as Sheriff ends in November.
- o Hopkins states the Fair Board has met and they will be making provisions to be sure the Sheriff's Department will be visible at the Ogle County Fair.

New Business -

- o Petrizzo asks about the document included in the packets and states it is interesting enough to place on the agenda for discussion next month. Chairman Gouker states this discussion would benefit best for discussion at the County Security Committee Meeting.
- o Nordman comments on the report and would like to be reassured that the people involved know what the deficiencies are and they are to be corrected.
- O Chairman Gouker states this report was issued by IEMA which is done after every exercise. We can have the Regional Coordinator from Lee County come in and review the report. Chairman Gouker states a second demonstration was held and the County properly executed the drill the second time.
- Sparrow states he does not remember this information being discussed at the County Security Committee meeting. Janes states this could be added to the agenda for discussion. Chairman Gouker states they could ask for the Regional Director from Dixon to attend the meeting as well.
- o Gronewold states a situation has come up in regards to issues with the electronic recycling program through the Solid Waste Department. The Solid Waste Director Steve Rypkema would like to use the back of Pine Road Annex Building. There is some livestock equipment which has been in storage since 2001 which was purchased from a Grant for Mad Cow Disease. Gronewold is asking for permission to have the equipment stored at the fairgrounds and possible use of the equipment at the Fair. Gronewold will be bringing this before the committee meeting next week, but I need to have the equipment moved next week. The consensus was to allow the Fair Board to store and use the equipment.
