Zoning – #2-15 SPECIAL USE - Byron-Oregon Sportsman & Conservation Club – O-2016-0101

Janes presents the petition of Byron-Oregon Sportsman & Conservation Club, Inc. % Oscar K. Welty III, President, 1509 E. Town Line Rd.- PO Box 742, Byron, IL for a Special Use Permit to allow a shooting range in AG-1 Agricultural District on property described as follows and owned by the petitioner: Part of the W1/2 of the NE1/4 and part of the E1/2 of NW1/4 of Section 2 Rockvale Township 24N, R10E of the 4th P.M., Ogle County, IL, 19.93 acres, more or less. P.I.N.: 09-02-126-002 – Common Location: 1509 E. Town Line Rd. – Janes moves to approve O-2016-0101 as presented and Simms seconds.

Meyers reads a prepared statement: "I was told by a board member that the residents had to prove that their property would be negatively impacted by the building of the pistol range. They did prove it, but it fell on deaf ears. In fact even the remarks of the people have been left out of the committee minutes numerous times as well as mine. Why is that? Their property values will decrease, their peaceful existence will cease but more than anything else their safety will be jeopardized.

Also affected by your decision are the residents of Ogle County who use the beautiful serene forest preserve for recreation. How serene and safe is this going to be when there is pistol fire 365 days a year, all day long and some evenings. A plea against the pistol range from The Byron Forest Preserve board also fell on deaf ears.

This land was approved by the Ogle County Board for a subdivision and rural residential lots and now you are asked to change the rules.

The residents and the Byron Forest Preserve are asking you to preserve their rights. Please vote NO for this special use permit."

Hopkins states this has been the most controversial issue we have had in Zoning for quite some time. He has checked out the area; with the population area, Forest Preserve and Parks it doesn't seem like this is an area for this type of request.

McKinney voices his is concern with the safety of the residents in the area and will be voting no on the issue.

Fritz has spent time visiting other gun clubs in the area. The Sportsman Club has made changes that were first proposed and were reflected on what the neighborhood residents wanted. The visits made at the Ogle County clubs, none of them were enclosed. Fritz has talked to many of the people involved on both sides looking for something to stand out and hasn't found it. If this were something in my backyard would I want it there? The answer is no in my opinion, states Fritz.

Colson informs the board there were 14 conditions attached to the request primarily in safety and in consideration of other things. After the Planning, Assessment and Zoning Committee was locked-up in a tie vote; Zoning Administrator Mike Reibel added 7 more conditions which brings it to a total of 21 conditions to ensure the way it is operated and the inspection process. Colson feels this has answered all of the concerns which have been raised.

Simms states she is on the Planning, Assessment and Zoning Committee and has read all of the documentation and concerns on this request. Simms feels this gun club is a huge asset to Ogle County and will be the only enclosed facility in Ogle County. What an opportunity for Ogle County to have a building designed by a professional engineer to ensure the safety of everyone around. Simms will be voting in favor of this.

Saunders believes in the Concealed Carry Law and would like to have a place like this to shoot. I don't like the way we have come to the conclusion because so much of what was promised was not under sworn testimony. The area is too populated and I would like to see this in a less populated area. Saunders will be voting no.

Chairman Gouker comments that zoning is a very difficult and emotional issue. But fundamentally it is about property rights of the petitioner and the neighbors in the area. We've already said we need a facility like this. But are we in the business to determine where this should go or are we in the business to determine when someone comes with an application that they have satisfied the concerns of the neighbors so they can use their property as well? There

are two fundamental issues here, can they provide for the safety and can they reduce the level of sound. There are 21 restrictions on this zoning amendment. Gouker feels this is the definition of compromise.

Colbert says she believes this is a quality of life issue and our number one priority should be to protect the communities. Colbert will be voting for what is best for the most people involved and the good of Ogle County. Colbert will be voting no.

- o Barb Graham Oregon, Chapter Leader for the Well-Armed Woman Speaks about how safe this gun range would be and the need for this facility for people to shoot their guns.
- O Lynn Courta Byron, Rockvale Heights Subdivision There have never been any accidents or problems at the gun club. She is concerned with the voting down of the request; we do not live in a safe environment. You have voted down a place where we can legally and safely practice shooting our guns. She is more concerned about the people walking around on the Forest Preserve property.
- o Amy Eder Byron, Rockvale Heights Subdivision This neighborhood is not the correct location for this type of facility.
- O Ken Conti Townline Rd This is not a gun issue; this is a zoning issue. This has been zoned for clay pigeon shooting for many years. The Assessment, Planning Zoning Committee may have had a difficult time, because they have to make the decision based on the zoning standards not what may be good or bad. Conti commends the County Board on the decision they made this evening.
- o Oscar Welty III Thanks the board for their time and consideration on this issue.
- o Deb Toney Mt Morris Asks if not at this location, where?
- o Bethany Wiltshire Deer Path Rd Her family are FOID cardholders, go hunting and have guns. She thanks the members who have kept separate the issues of gun ownership and the rights of gun ownership from your roll in the zoning of Ogle County. This issue was a zoning issue and thanks the board members for their vote tonight.
