Re: Marriage License Procedure

An Ogle County marriage license can **ONLY** be used for a marriage ceremony that will occur within Ogle County. A license needs to be gotten at least 24 hours before the wedding date and is good for 59 days after issuance. In our efforts to make the Marriage License process as quick and easy as possible during the COVID-19 restrictions use the following procedures.

- 1) BOTH parties must come into our office with the following documentation
 - a. Complete the highlighted portions of the attached application
 - b. Birth Certificates
 - c. Photo ID
 - d. \$40 Payment
